A.INTRODUCTION & TIMETABLE

The BAFTA Scotland Awards are presented annually to recognise, honour and reward outstanding achievement in film and television produced in Scotland, and Scottish individuals working in these industries.

The Academy also honours individuals with awards in recognition of their contribution to the industry. These awards are in the gift of the Academy, they are approved by the BAFTA Scotland Committee and ratified by the Board of BAFTA.

B. ELIGIBILITY

- Each entry must be a complete programme/film/production. Inserts are not eligible. Recut, reversioned, renamed or repeated productions are not eligible
- Productions must meet Screening Eligibility and Scottish Qualifying Eligibility as outlined below. Further specific category eligibility is outlined in <u>Awards Categories</u>
- Any entry that has previously been submitted will not be considered eligible
- Programmes scheduled to have episodes from one series in two separate eligibility periods cannot enter the same series in two consecutive years
- Unless otherwise specified in the rules of the category (e.g Feature Film, Short Film & Animation) all entries must have a minimum scheduled running time of 3 minutes.
- In television production categories, short form programmes may enter up to 3 episodes from a series, capped at a total of 30 mins duration including credits. Episodes must be from the same series, must be consecutive episodes in the series and must be complete episodes (edited clips/scenes from episodes will not be permitted). Episodes should be compiled into one video file, and should run continuously without any internal editing with blank screens between episodes (please include credits on the end of each episode).
- All Gaelic entries must be submitted with English subtitles
- Entrants may be asked for clarification on information provided at entry. If you are in any doubt about eligibility please contact the Awards Team before submitting

Screening Eligibility

- **Television Programmes** must have had their first transmission in the UK between 2 May 2024 1 May 2025 on terrestrial, cable, satellite or digital channels (or their online platform), including web based broadcasters who commission content (e.g. Netflix, Amazon Prime, YouTube Originals, Apple TV+)
- Feature Films must have had a theatrical release and been screened and marketed to a public paying UK audience (for at least seven days) during 2 May 2024 1 May 2025. Films without a confirmed and published theatrical release (listed on FDA www.filmdistributorsassociation.com) may qualify for consideration should they release on an approved commercial VOD platform and meet entry criteria, these films will be considered by the Awards Subcommittee before being approved as eligible. At the committee's discretion, and only in exceptional circumstances, a film which has been available to the UK public through other patterns or forms of distribution may be considered for entry; please contact the Awards Team as soon as possible if you wish to appeal for consideration. Feature Films should not be screened purely to qualify them, and the Awards Subcommittee will not accept an entry that otherwise meets criteria if they do not deem the release to have been meaningful.
- Short Films must have been screened at an Approved Festival between 2 May 2024 1 May 2025

Scottish Eligibility - Television and Short Film & Animation

All entries should satisfy two of the three following criteria:

- The production company has a substantive business and production base in Scotland. A base will be
 taken to be substantive if it is the usual place of employment of senior executives and personnel
 involved in the production in question
- At least 50% of the production budget (excluding the cost of on-screen talent, archive material and copyright costs) was spent in Scotland and/or on Scottish production talent
- At least 50% of the production talent (i.e. not on-screen talent) must have their home or usual place of employment in Scotland (currently residing and resident for a minimum of six years when the entry was made. British Passport holders who have relocated to Scotland may be considered eligible on a minimum of two years' residency and a proven commitment to working in the Scottish industry). This



must cover a minimum of four out of the following nine areas: Director, Producer, Developer, Animator, Writer, Line producer/Production manager, HOD – Art, Sound, Camera, Post Production, Music. (For factual entries, up to two of these roles may be replaced by Editor and/or Assistant Producer)

Scottish Eligibility - Feature Films

All feature film entries should satisfy two of the three following criteria:

- The production company has a substantive business and production base in Scotland. A base will be
 taken to be substantive if it is the usual place of employment of senior executives and personnel
 involved in the production in question
- At least 50% of the production budget (excluding the cost of on-screen talent, archive material and copyright costs) was spent in Scotland and/or on Scottish production talent
- A film must have significant creative involvement by individuals who are Scottish

Films that do not meet this criteria but have a significant Scottish component may be considered eligible, please contact the <u>Awards Team</u> as soon as possible should you wish to appeal for consideration. The BAFTA Scotland Awards Committee will make all final decisions on the eligibility of entries.

Scottish Eligibility - Individual Categories: Performance and Craft

- Any Scottish individual is eligible to enter for their work on any production. Individuals are considered Scottish under the following criteria: Scottish place of birth or identifies as Scottish having spent a considerable amount of time based in Scotland, this could include formative years
- Any Individual is eligible for work on any Scottish Qualifying Production (see above)

The BAFTA Scotland Awards Subcommittee will make all final decisions on the eligibility of entries, and may refer to other BAFTA Awards criteria (BAFTA Film Awards, BAFTA Television Awards, BAFTA Television Craft Awards, BAFTA Games Awards) on certain eligibility queries.

C.FNTRY

- All entries should be made via the BAFTA Awards entry site: entry.bafta.org
- The entry site will be open from 12.00 on **Wednesday 19 March**. Entrants are advised to begin the entry and video upload process early to avoid missing deadlines
- The submission and payment deadline is 17.00 on Thursday 1 May
- Entry fees are dependent on category see <u>Award Categories</u> section for fees
- All entry fees must be paid online via the entry site by the submission deadline. Entries cannot progress
 to voting until payments are settled. Entries will not be approved from entrants with previous debts until
 payments are settled
- Entry is open to producers, directors, broadcasters, independent production companies, BAFTA
 members and individuals included on the credits of a programme/film. Individual entrants, e.g.
 Performance and Craft, may submit their own work but will need to source all required information
 and materials
- The selection and submission of episodes, programmes and films is the responsibility of the entrant any individuals who are being submitted for consideration should be consulted directly by the entrant.
- Multiple categories can be entered on the same entry form, provided they are all being entered for the same episode/film. Select the production category to be entered first, then individual categories can be entered later in the same form. If different episodes are being entered to represent different



- categories, then a separate entry form must be completed for each episode. For entry form queries contact the <u>Awards Team</u>
- All entrants will be asked to provide the contact details for the producer of the programme who may
 be contacted to confirm credits. A lead contact from the production being entered must be
 provided. Direct/representative email addresses must also be provided for all individual entries should
 BAFTA need to contact them directly.

Special notes

- All categories must have eight entries to run (with the exception of Feature Film, which may run with six
 entries in exceptional circumstances), any category with fewer entries will not be presented but entries
 may be eligible to enter the following year at the discretion of the Awards Subcommittee, or
 categories may be merged/entries moved. All Individual category entries (actor, actress, director,
 writer) relating to a particular programme/film which is being carried over to the following year must
 be entered in the current year.
- Entrants may submit different episodes of the same series in Individual categories for different performers/directors/writers, but only one episode can be submitted in a Production category.
- Three nominations will be presented in each category that has received up to 19 entries. Four nominations will be presented in categories that have received 20+ entries. If one gendered category reaches 20 entries both will automatically receive four nominations.
- Should an exceptionally high number of feature length dramas and documentaries be submitted in the Feature Film category, during the review of entries, the Awards Subcommittee may opt to present both a Feature Drama and Feature Documentary award
- Due to being under review the Game category will not be presented in 2025
- Specialist Factual will not run in 2025, entries should be submitted in another relevant category (e.g.
 Factual Series or Single Documentary). The Features category no longer exists, being updated to
 Factual Entertainment, refer to <u>category definitions</u> before submitting in any category as updates may
 have been made for 2025

Entry Process

The following will be required for submission (category dependent):

- Information on the entry meeting Standard C of the <u>BFI Diversity Standards Screen Scotland Pilot</u> (mandatory)
- Information pertaining to whether the entry meets any other <u>BFI Diversity Standards Screen Scotland</u> <u>Pilot</u> (voluntary)
- Upload of the company/production Bullying & Harassment policy (mandatory)
- Confirmation on whether the programme is Albert Sustainable (voluntary)
- A synopsis of no more than 300 characters. This should be a factual synopsis of the film/episode and should not include any details of other awards won, ratings or media quotes. BAFTA reserves the right to edit any synopsis
- Proposal of names of up to six individuals to be listed as nominees if the programme receives a
 nomination, except Short Film & Animation where up to four individuals may be listed. These are the
 'candidates for nomination'. Failure to propose names may render your entry invalid. See <u>Candidates</u>
 <u>For Nomination</u> for guidelines
- Direct email address or agent/representative email address per candidate/individual submitted, as it
 will be necessary for BAFTA Scotland to contact these individuals in the event of a nomination. All
 details will be retained in accordance with <u>BAFTA's Entrant Privacy Policy</u>. A lead contact from the
 production being entered must also be provided.
- The full programme/film uploaded to the entry form via your Media Library



- One landscape publicity image to be used as thumbnail for BAFTA View (16:9, min. size 436x245px but larger preferred)
- Three production stills from the programme episode entered which can be used by BAFTA in the event of a nomination. Images must be high resolution JPEG or TIFF files, min. 600px wide. These stills should be representative of final broadcast, not publicity images/headshots/artwork
- The final script should be provided for the Writer Film/Television and Director Fiction categories.
- A PDF containing a full list of credits for the series including both title and end credits. In the case of short form programmes when up to three episodes have been entered as one video file, full credits for each episode should be uploaded as one PDF document.
- BAFTA may require a captioned/subtitled version of your entry. It is not mandatory to upload this at the entry stage, but must be provided if requested at any point
- **Performance categories** an additional still will be required for the performer, which may be used on the voting site and in the event of a nomination. A clips reel can be submitted for performers who are being entered for a series; this can be up to five minutes' duration and should run continuously without any internal editing (blank screens between clips will be accepted). The intention is to show the performers work across a series and should not be an edited show reel. The reel should be uploaded to your entry form via the Media Library
- **Gender identity** BAFTA is requesting that the gender and/or gender identity is provided for all potential candidates for nomination across all entries and for entrants to individual categories. This is to inform ongoing research into gender in our industry, and BAFTA's research regarding gendered categories. Additionally, providing this information is mandatory in Director Fiction, Director Factual and Writer Film/Television as there is an intervention in these categories (outlined in Voting). The information gathered is anonymised and processed in compliance with BAFTA's privacy policy. By submitting this data you are agreeing that the individual consents to this information being provided and that it can be stored and used in compliance with our privacy policy.

Legal Entry Conditions

Upon submitting, entrants must confirm that there are no open issues relating to the production which would bring BAFTA into disrepute, should this information come into the public domain. BAFTA reserves the right to change and/or withdraw named candidates/nominees at any point of the entry and judging process and post nominations, and to rescind and/or suspend any nomination or award. In the event that BAFTA is made aware of information relating to the film/programme/series or about anything or anyone involved in its production or distribution, or relating to an individual, which is capable of bringing BAFTA into disrepute, BAFTA shall, in its absolute discretion, be entitled to suspend, revoke or rescind any entry or nomination, or impose such other conditions as it shall consider reasonable in the circumstances. The criteria by which a competitive award would be considered for revocation is:

- If a television programme, film, or individual is proven to have used duplicitous and/or illegal methods in the course of making their work
- If a television programme, film, or individual is found to have made their entry with false information or information that renders their application ineligible

The criteria by which a competitive award presented in/after 2025 would be considered for revocation is:

• If an individual named winner is found guilty by the UK courts of any criminal offence and is sentenced to a term of imprisonment of three months or more (whether or not suspended)

CANDIDATES FOR NOMINATION

You must specify how you wish to list the nomination publicly by choosing either:

- (1) Candidates for nomination: individual names will be made public if nominated; the individuals can call themselves 'BAFTA Scotland winning'
- (2) Production team representatives: nomination listed as 'production team' if nominated, names not made public. Please note that it is the programme that is being recognised, not the individuals, and these individuals will not be able to refer to themselves as BAFTA Scotland nominees or winners.

There must be careful consideration of who is proposed to be listed for nomination - changes cannot be made once nominations have been announced, so it is the responsibility of the entrant to ensure this information is correct at the point of entry.



Up to six names can be put forward as named nominees or production team representatives (excluding Short Film and Animation where up to four names can be put forward). Names submitted must be those that have made up of the core creative team and those who lead creative contribution to the programme. These individuals must have worked on the series that has been submitted for consideration but need not be credited on the episode submitted. Commissioning editors and executives who work within the broadcaster commissioning teams will not be accepted. Names should be submitted on the entry form in the order they would be listed should a nomination be received. Where an agreement cannot be made on candidates, BAFTA will use the episode supplied as the final arbiter for candidates. The BAFTA Scotland Awards Subcommittee retain the right to question the eligibility of any individual put forward.

Scripted the writer, director and producer should be submitted as candidates. Executive producers, production managers and line producers would be accepted if the candidate had creative contribution and if the above credits have not been omitted. Other creative roles may be considered but are at the discretion of the Awards Subcommittee.

Non-scripted the producer and director should be submitted, followed by any others who had creative control over the programme. This may include roles such as the lead editor, writer, line producer, production manager and executive producers, if the candidate had creative contribution and if the above credits have not been omitted. Presenters will only be accepted on the basis that they have significant involvement at a senior editorial/creative level equivalent to the above roles, and a statement must be included on the entry form explaining their contribution.

Candidates for nomination and production team representatives are reviewed at entry, at which point entrants will be contacted for more information where necessary. By submitting the entrant confirms that names provided have been agreed upon with the entire senior team. In the event that a decision on candidates for nomination cannot be agreed upon and a nomination is received, BAFTA reserves the right to list the nomination as 'production team' and the names not be made public. The final decision on eligibility rests with the BAFTA Scotland Awards Subcommittee. Only the individuals named as candidates for nomination or production team representatives on entry forms will be eligible to order trophies should the entry go on to win (see Trophy Policy)

APPEALS Any names submitted outside the above guidance should outline why in the Appeal section of the entry form. We are aware productions may operate differently so other creative roles not typically eligible may be accepted as a candidate on an appeal basis. For this reason, roles accepted in any one year or entry does not mean automatic inclusion in another year or entry. BAFTA nominees are under intense scrutiny. Every candidate and entry is checked thoroughly to be as fair as possible in the process. All exceptions may set a precedent so will only be given on case-by-case basis. BAFTA reserves the right to remove or query any individuals not listed who have an eligible credit or any of those that are listed outside of the above roles.

Correct entry information is the responsibility of the entrant. BAFTA is not liable for errors in listings that are the result of incorrect information submitted on the entry form.

D.BFI DIVERSITY STANDARDS – SCREEN SCOTLAND PILOT

In certain categories, as agreed between the BFI, BAFTA Scotland and Screen Scotland, entrants will be asked if their project would meet the BFI Diversity Standards – Screen Scotland Pilot, with meeting Standard C being mandatory.



The BFI Diversity Standards were launched across the UK in 2016. They encourage equality of opportunity and address under-representation in the screen industries – in creative leadership; crew and project staff; in training, opportunities and career progression; in audience outreach and development; and on-screen. They are a flexible framework which can be used for feature films, television content produced for broadcast and online, as well as a range of audience-facing activities such as film festivals, distribution releases, multiplatform distribution proposals and ambitious film programmes.

Screen Scotland has worked with BFI to develop a version of the BFI Diversity Standards that will apply to Scotland based projects and which reflect the Scotlish population structure, they can be found here.

Entrants will be asked to self-assess against these standards. BAFTA may request further clarification on information provided. This information will be requested from entries in the following categories: Entertainment, Factual Series, Feature Film, Factual Entertainment, News & Current Affairs, Single Documentary, Short Film & Animation and Television Scripted.

It is mandatory that entries in the above categories meet Standard C – Industry Access and Opportunities, by meeting two of the five criteria listed in the BFI/Screen Scotland Diversity Standards, found here. Details of which criteria have been met and how must be outlined on the entry form. Concessions may be made in exceptional circumstances and on a case-by-case basis. If your entry does not meet Standard C, please contact the Awards team to appeal (see <a href="https://example.com/contacts/com/here.com/

Entrants can then voluntarily provide information in support of meeting other Standards. Qualification in Standards (other than Standard C) will not affect eligibility and has no impact on funding awards previously made by Screen Scotland. The intention is to encourage better representation and increased inclusivity across the industry, and the supporting information gathered will help the BFI, BAFTA and Screen Scotland define what diversity standards should be applied to the production process and awards eligibility in the future.

The 2025 BAFTA Scotland Awards application form asks those submitting projects to confirm which specific Standards they have met, to provide more detail on how it has met/not met the Standards and detail any diversity inclusion programmes that the company run that are not listed as part of the standards.

E. MAKING PROGRAMMES & FILMS AVAILABLE TO VOTERS AND JURORS

- Entrants must upload their programmes/films via the entry form. All uploaded programmes/films going through the membership vote will then be made available to BAFTA members on BAFTA View. These programmes must be submitted as originally broadcast, minus commercial breaks. Entry forms cannot be submitted without a video upload.
- BAFTA members will be able to start watching entries on BAFTA View before voting opens. BAFTA
 will send updates informing voting members of every programme entered periodically, so it is
 strongly encouraged that entrants submit as early as possible to give BAFTA members a greater
 opportunity to view material under consideration ahead of voting. Nominated productions may
 remain on BAFTA View for members to review until the date of the ceremony.
- BAFTA View is username and password protected via two-step verification and is only accessible
 to jurors and voting BAFTA members. For further information on the security controls in place to
 protect streamed and downloaded content, please email awards@bafta.org



F. TECHNICAL SPECIFICATION

The BAFTA Awards Entry site and BAFTA View aims to provide the best possible viewing experience for your content. In order to achieve this, we request that you provide a high quality version of your file. Please use the preferred specification (below) where possible, however if your original best quality video is in another format, we would prefer to receive it with minimum encoding to preserve quality.

Awards in the Gift of the Academy

These awards are presented at the discretion of the BAFTA Scotland Committee; they may not all be presented in any given year

1. BAFTA SCOTLAND AWARD FOR OUTSTANDING ACHIEVEMENT

For outstanding achievement in film, television, broadcasting or games

2. BAFTA SCOTLAND AWARD FOR OUTSTANDING CONTRIBUTION FOR CRAFT (IN MEMORY OF ROBERT MCCANN)

For outstanding contribution to craft

Production Categories

Unless otherwise specified in the rules of the category (e.g Feature Film, Short Film & Animation) all entries must have a minimum scheduled running time of 3 minutes. All entries must meet Screening/Scottish qualifying criteria, see Eligibility

3. ENTERTAINMENT

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- Includes chat, game, talent, panel, quiz, sketch, children's entertainment, music shows, stand-up (where
 created for television), reality competition (in which the participants are taking part in a game, task or
 situation devised by the producer) and live or recorded entertainment event coverage (maximum one
 hour of live entertainment event coverage can be uploaded running continuously without any internal
 editing)
- With the exception of short form programmes, only one episode from an eligible series should be submitted for consideration. In the event of being shortlisted for jury consideration, only the episode submitted via the entry site will be considered
- Short form programmes may enter up to 3 episodes from a series, capped at a total of 30 mins duration including credits. Episodes must be from the same series, must be consecutive episodes in the series and must be complete episodes (edited clips/scenes from episodes will not be permitted). Episodes should be compiled into one video file, and should run continuously without any internal editing with blank screens between episodes (please include credits on the end of each episode).

4. FACTUAL ENTERTAINMENT

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For formatted features and factual programmes including fact ent formats, constructed reality, travelogues, cookery, cookery and craft competitions, gardening, property, fashion, and all other lifestyle programming and studio discussions. Includes some formatted factual reality where subjects act according to repeating or consistent format rules.
- With the exception of short form programmes, only one episode from an eligible series should be submitted for consideration. In the event of being shortlisted for jury consideration, only the episode submitted via the entry site will be considered
- Short form programmes may enter up to 3 episodes from a series, capped at a total of 30 mins duration including credits. Episodes must be from the same series, must be consecutive episodes in the series and must be complete episodes (edited clips/scenes from episodes will not be permitted). Episodes should be compiled into one video file, and should run continuously without any internal editing with blank screens between episodes (please include credits on the end of each episode).



5. FACTUAL SERIES

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- A single episode of a series of more than one factual programme linked through a unified approach, narrative or the thematic development of a subject matter, including 'reality' programmes in which the formatting consists only of a producer setting up an initial situation which is then observed unfolding without further intervention. Individual episodes of strands should submit into the Single Documentary category
- With the exception of short form programmes, only one episode from an eligible series should be submitted for consideration. In the event of being shortlisted for jury consideration, only the episode submitted via the entry site will be considered
- Short form programmes may enter up to 3 episodes from a series, capped at a total of 30 mins duration including credits. Episodes must be from the same series, must be consecutive episodes in the series and must be complete episodes (edited clips/scenes from episodes will not be permitted). Episodes should be compiled into one video file, and should run continuously without any internal editing with blank screens between episodes (please include credits on the end of each episode).

6. FEATURE FILM

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For feature films or feature length documentaries of over 70 minutes' duration which meet screening and production criteria see Eligibility
- Feature length documentaries are eligible to enter either Feature Film or Single Documentary, but not both. If a feature length documentary was intended to receive its first exhibition as a public, paid-entry cinema screening and has a subsequent eligible release, it should be entered in Feature Film, if the first exhibition was a television broadcast it should be entered into Single Documentary

7. NEWS & CURRENT AFFAIRS

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For an individual news programme (maximum one hour of coverage can be uploaded running continuously without any internal editing)
- For single films, or films from a strand that are primarily concerned with unfolding current affairs. Films led by an established current affairs reporter and/or from current affairs strands such as Disclosure, Dispatches, Panorama should usually be entered into this category. Programmes will demonstrate a commitment to original journalism of the highest order and will aim to provide revelation, fresh insight and analysis. If a film is strongly observational in character, entrants may appeal for the film to be entered into the Single Documentary category, but the final decision on categorisation will rest with BAFTA.

8. SHORT FILM & ANIMATION

- Entry fee: £50 ex VAT (£60 inc VAT) per entry
- For fiction, documentary and animation with a minimum duration of two minutes and a maximum duration of 40 minutes in length including end credits
- Inserts are not eligible; each entry must be a complete programme/film/production. Entries that are part
 of a television programme/series, feature film or music promotional video are not eligible



9. SINGLE DOCUMENTARY

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For one-off documentaries only. Includes individual episodes of documentary strands (such as Storyville
 or Imagine). May be presenter-led, however, if the presenter is an established news and current affairs
 reporter, then the programme should be entered into the News & Current Affairs category. The
 exception to this would be if the programme is observational and based on the reporters lived
 experience.
- Feature length documentaries are eligible to enter either Feature Film or Single Documentary, but not both. If a feature documentary was intended to receive its first exhibition as a public, paid-entry cinema screening and has a subsequent eligible release, it should be entered in Feature Film, if the first exhibition was a television broadcast it should be entered into Single Documentary

10. TELEVISION SCRIPTED

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- Entries can be single, serial or continuing drama, children's drama or narrative comedy shows
- With the exception of short form programmes, only one episode from an eligible series should be submitted for consideration. In the event of being shortlisted for jury consideration, only the episode submitted via the entry site will be considered
- Short form programmes may enter up to 3 episodes from a series, capped at a total of 30 mins duration including credits. Episodes must be from the same series, must be consecutive episodes in the series and must be complete episodes (edited clips/scenes from episodes will not be permitted). Episodes should be compiled into one video file, and should run continuously without any internal editing with blank screens between episodes (please include credits on the end of each episode).

Individual Categories – Performance, Craft

See <u>Eligibility</u> for Screening/Scottish eligibility that apply to all categories

11. ACTRESS TELEVISION 12. ACTOR TELEVISION

- Entry fee: £83.33 ex VAT (£100 inc VAT) per performer
- For a Scottish Actor or Actress in a television production
- For a non-Scottish Actor or Actress in a Scottish television production
- Both lead and support performances are eligible in this category

13. ACTRESS FILM 14. ACTOR FILM

- Entry fee: £83.33 ex VAT (£100 inc VAT) per performer
- For a Scottish Actor or Actress in a feature film of over 70 minutes' duration
- For a non-Scottish Actor or Actress in a Scottish feature film of over 70 minutes' duration
- Both lead and support performances are eligible in this category



16. DIRECTOR FACTUAL

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For a Scottish Director's work on any production
- For a non-Scottish Director's work on a Scottish production
- Entries can be television programmes or feature documentaries which meet screening/exhibition eligibility
- Individuals can be entered for different episodes of the same series
- In the case of co-directing credits where one individual is Scottish, the Scottish director should be
 considered the lead director and will be the only candidate listed for nomination. The entrant will be
 asked to confirm that this is agreed upon with the entire senior team/directing team. For further
 information, please contact the Awards Team

17. DIRECTOR FICTION

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For a Scottish Director's work on any production
- For a non-Scottish Director's work on a Scottish production
- Entries can be television programmes or feature films which meet screening/exhibition eligibility
- Individuals can be entered for different episodes of the same series
- In the case of co-directing credits where one individual is Scottish, the Scottish director should be
 considered the lead director and will be the only candidate listed for nomination. The entrant will be
 asked to confirm that this is agreed upon with the entire senior team/directing team. For further
 information, please contact the Awards Team

18. WRITER FILM/TELEVISION

- Entry fee: £158.33 ex VAT (£190 inc VAT) per entry
- For a Scottish Writer's work any production
- For a non-Scottish Writer's work on a Scottish production
- Entries can be television programmes or feature films which meet screening/exhibition eligibility
- Individuals can be entered for different episodes of the same series
- In the case of co-writing credits where one individual is Scottish, to be eligible the Scottish writer should be considered the lead writer and will be the only candidate listed for nomination. The entrant will be asked to confirm that this is agreed upon with the entire senior team/writing team. For further information, please contact the <u>Awards Team</u>

Category selection is the responsibility of the entrant; BAFTA accepts no responsibility for which category is entered but may move entries deemed to be in the wrong category. The BAFTA Scotland Awards Subommittee is the arbiter of all eligibility, and may opt to split or merge categories after the entry deadline



H. VOTING PROCESS

- The BAFTA Scotland Awards for Outstanding Achievement and BAFTA Scotland Awards for Outstanding Contribution for Craft are in the gift of the Academy
- Nominations and winners of all other awards are decided by BAFTA Scotland voting members and/or iuries:
 - Prior to Round One voting, all eligible members are informed of voting rules and must vote or register their abstention from any category. Voters are asked to rank their votes in order of preference.
 - The Members' top six in television-only categories will go forward for jury consideration along with broadcaster entries.
 - The top 8 in Actor/Actress Film will go to jury, raising to the top 12 if over 20 entries are received and four nominations are being sought.
 - The top eight (four men and four women) will go forward in Director Factual, Director Fiction and Writer Film/Television, this will raise to the top 12 (six men/six women) if over 20 entries are received and four nominations are being sought. Where a mixed gender pair, or gender diverse/non-binary entrants are progressing to round two gender parity will be upheld.
- Entries in Feature Film and Short Film & Animation go straight to jury consideration. Where there are high entry numbers in these categories additional jury rounds may take place. Any category with fewer than twelve entries will go straight to jury consideration
- Voting is conducted online and is authenticated by BAFTA's appointed independent scrutineers

Broadcaster Entries

After the membership vote each broadcaster will have the opportunity to re-enter one entry per category. Broadcaster entries can only be made in Television-only categories that have gone through the membership vote.

Juries

Juries decide the nominations and overall winner in each category by rounds of discussion and private ballots. Each jury will normally comprise of up to eight jurors plus a Chair, however, can proceed with a minimum of six jurors (or five in extenuating circumstances). Juries are comprised of industry practitioners across a range of broadcasters and independent production companies. Members of the BAFTA Scotland Committee will chair each jury. The jury process is confidential and authenticated by BAFTA's appointed independent scrutineers.

All decisions made by BAFTA Scotland and its juries are final and no correspondence will be entered into as to why particular entries were or were not nominated

I. LONGLIST, NOMINATIONS AND WINNERS

- Nominations for each category will always be listed in alphabetical order by title or individual's name
- Nominations will be announced approximately five weeks before the ceremony
- The winners press release is the definitive source of award winner information



- One BAFTA Scotland Award is given per win. In production categories the trophy must be accepted
 an individual credited on the entry form as a candidate for nomination or production team
 representative. This individual will then not be eligible to order a trophy, but other named nominees
 can (see <u>Trophy Policy</u>)
- For nominated non-binary performers, in the event of a win, the reference to gender can be removed from the trophy and/or certificate to read as 'performer'. Any nominees who wish to do this should notify the Awards Team ahead of the ceremony date
- The BAFTA Scotland Award or logo may not be reproduced or used in any commercial manner unless prior permission has been obtained from BAFTA Scotland. To request the awards logo please contact Sarah Hendry see <u>Contact List</u>
- The BAFTA Scotland Award remains the property of BAFTA Scotland and should remain in the care of the recipient or his/her descendants. Should the Award leave the care of the recipient or his/her descendants, the Academy reserves the right to purchase the BAFTA Scotland Award back for a fee of £1. The Award must not be sold on to any third party
- Award winners unable to collect their Award on the night of the ceremony must arrange collection within 6 months of the ceremony

J. CLIP USAGE - NOMINATED PROGRAMMES/FILMS

Clips from nominated productions will be shown at the BAFTA Scotland Awards ceremony and may form part of the television and online broadcast of the ceremony in the UK and around the world.

In the event of the production being nominated you undertake to deliver any clips, stills or other production materials as requested by BAFTA Scotland in the designated format and by any specified deadline.

Part of BAFTA's charitable remit is to promote excellence to as large an audience as possible. To fulfil this, BAFTA Scotland intends to make clips of the nominated productions available to the public on the BAFTA Scotland website and social media channels.

Owners of nominated productions may be required to submit to BAFTA a copy of the programme/film if requested. BAFTA and/or their production company will maintain such material under tight security.

By entering a production for consideration, the production's owners are deemed to have conveyed to BAFTA the right to choose excerpts from the production at BAFTA Scotland's sole discretion for incorporation into the worldwide television broadcast of the ceremony and on the BAFTA Scotland website and associated websites; including, but not limited to, bafta.org, guru.bafta.org, twitter.com/baftascotland, facebook.com/baftascotland, youtube.com/Baftaonline and instagram.com/baftascotland; for non-commercial purposes in the context of the Awards for one year from November 2025.

Upon entering via entry.bafta.org/ for the BAFTA Scotland Awards consideration, the entrant will be asked to confirm the following:

- That they have the authority, on behalf of the work to agree to grant the above license
- That they agree to grant the above license

If you foresee any problems with the granting of this license, please contact awards@bafta.org before entering.

K. BAFTA SCOTLAND LOGOS

- You may use the BAFTA Scotland logo online, in print and in broadcast if you have received a nomination, made a logo request and received approval from BAFTA (requests to be made to Sarah Hendry, see Contact List).
- The official event logo must be used; use of the mask alone is not permitted



- A summary of guidelines for use:
 - The Logo cannot be altered or cropped in any way
 - An exclusion zone (half the height of the BAFTA 'mask' all the way round the logo) must be observed
 - Example artwork(s) featuring the logo must be supplied for final approval and permission by BAFTA Scotland
 - The positive inversion of the mask is to be used on light coloured backgrounds; the negative on dark

I. PIRACY

O. TROPHY POLICY

One BAFTA Scotland trophy is given out at the Awards Ceremony, the recipient of which must be listed as a Candidate for Nomination or Production Team representative on the original entry form BAFTA Scotland is not responsible for which member of a winning team keeps the trophy after it has been awarded, but will keep a record of the individual's name as the recipient will not be eligible to order an additional trophy as the one given out on the night is considered theirs.

Additional trophies can be ordered by any individual/s credited in official BAFTA listings who did not keep the trophy given out at the Awards Ceremony, and this has to be done in writing directly by the individual via online application (details of the trophy application form can be requested following the ceremony via awards@bafta.org). Individuals credited in official BAFTA listings who did not keep the trophy given out at the ceremony can order a maximum of one trophy.

Trophies are £500+VAT and can be ordered up to six months from the day following the ceremony (after this deadline no additional trophy orders will be taken). BAFTA will confirm upon approval of your trophy purchase request if you would like arrange collection in person from BAFTA Scotland (free) or if you would like to add delivery (within mainland UK) for an additional £50+VAT per trophy. Please note trophy orders will take some months to fulfil.

Trophies cannot be ordered as gifts by a third party either for a credited individual or by the credited individual for a third party. The award may not be reproduced or used in any commercial manner. The award remains the property of BAFTA, to remain in the care of the recipient or their descendants. Should the award leave the care of the recipient or their descendants, BAFTA reserves the right to purchase the trophy back for a fee of £1. The award must not be sold on to any third party.
